3	Ensures proper PPE is being worn correctly						
4	Establishes mass decontamination corridor for ambulatory personnel						
5	Communicates EMS of the type of hazard(s) known or suspect						
6	Ensures decontamination corridor offers privacy to the extent possible						
7	Prepares apparatus for use						
8	Sets nozzle(s) to fog pattern						
9	Instructions persons to be decontaminated to carefully remove contaminated clothing						
10	Document or cause to be documented personal belongings: jewelry, wallets, etc.						
11	Instructs people to raise arms overhead as they proceed through the decontamination corridor						
12	Monitors for any additional decontamination that might be required.						
13	Instructs people to move to a clean area to dry off and provides them with a clean garment to don						
14	Directs (clean people) to medical evaluation station						
15	Ensure personnel, tools, and equipment are decontaminated						
16	Terminate decontamination operations according to AHJ's policies and procedures.						
17	Complete required reports and supporting documentation.
